



1. Do you oppose the proposed building of 700+ houses in our Parish?






3. Do you believe that Monahan Way should be the eastern limit of Carterton?


4. Has the arrival of the C-130 Hercules increased the level of nuisance noise from the base?



5. Will the further development of Carterton increase the traffic in our village?





6. Do you support Carterton Town Council's opposition to Carterton East?







The building of 700 properties would completely alter the structure of Brize Norton village. Traffic volume, probably flooding, population explosion, lack of working environment in reality turning a small village into a suburb of Caterton and probably in the future a suburb of Witney?? I have lived in the village for over 40 years and have never been refused insurance for my building (my home) - not even after the flooding just a few years ago. A few weeks ago I was refused insurance by 5 different companies. I managed on the sixth attempt. I can only assume refusals were made because the village is on a flood-plain, and with the threat of over 700 houses being built companies are aware and do no9t want to take risks in giving out policies should flooding increase. I cannot be the only one to be refused cover by several companies, and if property owners are unable to obtain cover then in my opinion WODC pay for any flood damage. After all it is they who have caused the problem by not giving assurances to companies and by poor planning. The DoE have stated that my property is not a flood risk. I cannot understand why anybody would want to create a residential area in an already environmentally unsuitable position. Who do they expect to live there? It is socially irresponsible to site homes so close to a noisy / light polluting / air polluted air base. To build on a site that will add to flood risk through water run off is simply nuts (the planners weasel answers when questioned are just not credible). To ignore the inevitable increase in local road traffic by not planning a joined up strategy is simply insulting. "As far as we are aware there are no proposals for improvements to the A40 east. All the local developments are just increasing the problem." Prior to residential development substantial sustainable and varied employment opportunities must be created. Financial incentives (as existing units stand empty) must be provided by the developers, local councils and central government. What financial incentives are on the table? If residential accommodation is completed before employment opportunities exist, Carterton will become a mixed garrison/dormitory town with no sense of community leading inevitably to social behavioural problems in the town and local area. 1) Bloor Homes consider that there is 'no noise polution' from RAF Brize Norton. The MOD, Prime Minister, Brize Norton Parish Council and the villagers all consider there is! Bloor Homes should reconise the truth! 2) Bloor Homes consider that only an additional 35 cars will drive through our village in the rush hour., A40 is already gridlocked which will only become worse with over 1,000 new homes in Witney. We will certainly see more than 35 cars with 700 new homes as people try and find an alternative route towards Oxford. Why is WODC putting their heads in the sand over this matter, why can they not admit to the obvious! Roads to and from Carterton cannot take any more vehicles! The A40 needs urgently to be widened to cope with the traffic we have presently. The schools in Carterton are not full at the moment, therefore another school is not needed. Has the Action Group given any thought to the provision of the link from Witney Rd/Curbridge/Astrop to the roundabout on the new road? This was promised when the first houses where built but never materialised. This is of vital importance to keep traffic out of the village. It is hard to believe that anyone would wish to buy a house so close to a major air base and where there is a proven risk of flooding. It follows that in all probablity there will be many left empty and therefore

a risk of vandalism. Not having to use the A40 or the A420 ,,, I think most of the RAF land where the flats have been demolished should be developed for housing ie drainage, roads, etcs all ready in place Creating addictional homes for say 1500 people of working age will put extreme pressure on the road system with the A40 already massively congested traffic will head South through the villages of Brize Norton and Bampton, Aston and Standlake to get to Oxford and Didcot (trains to London). These villages, the roads and the bridges over the Thames are inadequate to deal with the increased volume of trattic that will occur. The proposed 'East Carterton' site is a very poor one re: work prospects, noise and light pollution, road access to Oxford and flooding. I have lived in Brize Norton for 44 years the lease has been there for many more years - men are going to war and losing their lives we have no right to complain about noise I don't believe Carterton will provide any extra employment for the families who move into these houses and that they will still be commuting to Abingdon, Witney and Oxfordshire and, therefore, adding to the all ready busy roads, especially the A40 building houses so close to a 24/7 operational RAF base, particularly close to the engineering hangars makes no sense. Why would anyone choose to live in such a noisy environment and have their peace and enjoyment disturbed and poor quality sleep. If this plan goes ahead, undoubtedly RAF Brize Norton will receive noise complaints from the residents who should have considered the noise before they purchased! The A40 into Oxford is already beyond capacity, and one of the busiest roads into Oxford, with no plans to realistically improve travel links. An additional 1000 in carterton could produce 1000+ more people commuting to Oxford for work. The transport issues need to be addressed first before further development in Witney and Carterton This is an ill conceived plan. it appears to be another SOP to the riparian landowners - Christ Church College. The college appears to believe they have an undue influenced on West Oxford District Council . The plan is, rightly, rejected by Brize Norton Parish Council and an overwhelming number of parishioners. It has also been rejected, publicly be Carterton Town Council. There is amply room within Carterton to accommodate this number of house without creating further ugly urban spraw. Use redundant MOD landl None I fail to see the reasoning behind building approx. 700 houses in Carterton (including those within its boundaries) in such close proximity to Witney where it is proposed to build ANOTHER 1500+ houses. Where exactly will people work? The roads willo be even more congested. And the noise from the RAF base Any further Carterton houses should be within its own present boundary The B4477 road from Brize Norton to the A40 is already not fit for purpose, and cannot cope with any more traffic. They are proposing to destroy the buffer zone the parish of Brize Norton was promised when a large area of the parish was taken to build Shilton Park. The Country Park, Kilkenny Lane and Monohan Way were to be the boundary of Carterton and stop further ugly urban sprawl affecting the village of Brize Norton. The suggested so called "new" buffer zone cannot be a buffer as it is an incursion into the village. The development will affect the identity of the village and change the ;landscape for the worse. Also who will want to live in the houses so close to the noise and polution of the base? It does not make sense. As Carterton residents we are against any further housing development. As members of St Britius church for the last 30 years we fully support the village and the resident's concerns People living east of Carterton use Witney as their town (fact), Carterton Community College is half empty as Shilton Park send kids to Henry Box in Witney (fact). Development to West offer better inclusion to Caterton community and access to schools/amenities. For Carterton to move forward they need traffic coming through. Development on the West is the only way to ensure this happens. I chose to live in a village - not to be joined on to a town I am concerned about the future of our splendid village primary school If the houses are built the area will turn into a 'ghetto' as owners realise the noise is intolerable but cannot sell. Traffic through our village is already too great and will only get far worse as lack of local jobs means we all need to commute. My biggest concern is the poor quality of life for purchasers of the new homes as night time noise levels already exceed MOD guidelines. Mr Cameron is aware of the problem. It seems madness for any council to consider building houses so close to the busiest RAF base in the UK. This encroaches into one of the most famous villages in the world. The infastructure simply cannot cope and has already become a 'rat run' for commuters as there are no jobs in the area. Villages should remain 'villages' and not be swamped by towns. My greatest fear is that, due its close proximity to the base the new development will become a ghetto . The B4477 from Brize Norton to the A40 is already not fit for purpose, and cannot cope with additional traffic. A direct route

to Astall Barrow should have been planned in the first place. If Christ Church get planning permission they will build 1200 houses and their next target will be the other side of the Burford Road between the barns Lets keep Brize Norton as a village. I've lived there for 79 years. We were flooded by sewage after Shilton Park - 9 months out of our bungalow. Our concern is that the sewage beds can't cope. Also were will people work The traffic using the BN bypass is only a small proportion of the traffic going through the BN village. By more homes would increase this considerably and I won't imagine it would be like. "Every time I approach my house near the Masons Arms from the Methodist chapel, I see in my mind's eye where the 700 houses are planned and I feel so sad for our village. They will be an eye-sore, a cause of extra noise, traffic, pollution and a threat to flooding not good for anyone!" This area cannot take another housing development. The roads cannot cope now. We moved here 3 years ago and the level of noise has increased noticeably and the vibrations from the larger planes. The road infrastructure through the village is stretched as it is so a new housing estate would increase the problem to unmanageable levels Increase in traffic onto the A40 via the B4477 on a road that is already unable to cope. Several serious accidents have occurred and 5 fatal. Brize Norton, as a village, will no longer exist if this development is allowed to go ahead. There is no work or infrastructure to support more houses in the area All the objections that Carterton Town Council made to the Eastern Development are valid. The small changes that Bloor Homes made are purely cosmetic. As we find out more about noise pollution from the base it becomes clear, that to build next to it would be foolish in the extreme To develop residential accommodation in an area which is bedeviled by a high and varied level of polution (noise, air, light) is an act of social vandalism, because it knowingly reduces the quality of life that will be available to the people who purchase the properties. There are so many reasons NOT to do this - traffic/jobs/schools/making rat runs through surrounding area/people who live in villages not wanting to suddenly find themselves in a town/community will suffer/ could go on and on. As stated in previous letters: 1. Why 'Carterton' East when in Brize Norton. 2. I do not believe more housing is needed. 3. The infrastructure & facilities cannot cope. 4. Traffic will become a bigger nightmare. 5. We are opposite the field and it is inconceivable that 700 houses will not cause flooding Not just increased traffic in our village, but in all roads in the area as far as Oxford, which are already congested. Also the car parks in Witney are very busy now, not everyone will shop in Carterton We strongly oppose this development. It is a threat to our village life - our village school - and a huge increase in traffic through the village. There are limited job prospects in Carterton. The majority of residents travel to Oxford or Swindon to work. They access the A420 by driving through the village towards Bampton. Drivers have mainly abandoned Monohan Way 'because it is quicker to drive through Brize Norton'. The A40 is already a nightmare where on earth is more traffic supposed to go? The District Council seem unable to answer this question. I cannot see that local job prospects are going to improve. Businesses are deterred by the A40. As far as we are aware there are no proposals for improvements to the A40 east. All the local developments are just increasing the problem.
